CHERRY HILL CAMPGROUND RULES

Thank you for staying with us, we want to make sure that your stay is both pleasant and comfortable! If you need any information, please feel free to visit us in our Main Office. To help us make your stay and your fellow campers stay more enjoyable, we ask that you please follow these simple rules.

- **CHECK IN TIME** - ANYTIME AFTER 1:00 P.M.
- **CHECK OUT TIME** - 12:00 P.M. If we do not need your space and you wish to extend your stay with us, there will be an additional charge. All payment is required in advance of your stay and is based on current availability.
- **QUIET HOURS** - 10 PM to 8 AM. Generators prohibited.
- **NOISE** - Music, Movies, or other amplified noise should be played at a comfortable volume as to not disrupt others who are camping and are not permitted during quiet hours.
- **VEHICLES** - Motorized devices such as ATV's, Motorcycles, Motorized Scooters, and Golf Carts used for recreational use are not permitted at Cherry Hill.
- **RESTROOMS AND SHOWERS** - We have multiple facilities for our campers to use. One is located by our Main Office, the other is in our Campground. Due to Board of Health Regulations, animals and the washing of dishes are prohibited in the restrooms.
- **VISITORS** - Visitors are allowed as a courtesy. All overnight campers must register with our Main Office. Please have any visitors park in one of our parking lots. We DO NOT allow parking in empty campsites, on camp roads, or in any posted "No Parking" zones. Cars that are illegally parked may be towed at the owners expense.
- **MAXIMUM GUESTS ON A SITE** - Limit of ten (10) people per site. All rates include 2 guests in the price, additional guests (Age 4 & older) are \$4 per person, per night. You usually can fit one vehicle per site, as long as it is not blocking any roads or other sites. Any additional vehicles or vehicles that do not fit on your site MUST be parked in one of our designated parking lots.
- **TENT SITES** - If you plan to stay more than 4 days, it will be necessary to move your tent to another location to keep the grass from smothering.
- **WASHING** - The washing of RV's or vehicles is not permitted at Cherry Hill.
- **LAWN HOSES** - Lawn hoses and sprinklers in the campground are non-potable irrigation water and are for Cherry Hill use only.
- **SITE REQUESTS** - Specific sites are not guaranteed. When booking with Cherry Hill you are guaranteed a site according to your hook up needs. Cherry Hill Management will assign ALL sites prior to your arrival.
- **NON-FIRE CAMPGROUND** - Fire pits and grills are not provided on site. Personal propane, charcoal grills, and portable above ground fire pits are permitted. Hot coals must be fully extinguished and disposed in the dumpsters. Fireworks are prohibited in the campground, courtyard or public spaces. For additional information please see Cherry Hill Management.
- **TABLES** - One Orange picnic table is provided per site. Please do not move tables from other sites.
- **CHILDREN** - All children under the age of 6 must be accompanied by an adult throughout the park and in the rest rooms. Children are not allowed to play in the rest rooms.
- **PETS** - Animals must be leashed at all times and may not be left unattended. Animal owners are responsible for the care and clean-up of animal waste. Cherry Hill is neither in control of nor responsible for the behavior of a patron's animal, including any damage or injury resulting from a patron's animal. Except for service animals, animals are not permitted in the restrooms.
- **GARBAGE** - Help us keep our campground clean. Guests may obtain a free garbage bag from the Main Office. Please deposit it when full in one of our large garbage containers throughout the park.
- **SMOKING** - In accordance with Utah State Law, Cherry Hill is a smoke free recreational facility. Smoking is permitted only in designated areas. See our sight map for those locations.
- **TREES** - Trees, and the shade they provide, are an integral part of an enjoyable experience. However, healthy and well-maintained trees pose a natural hazard of falling debris such as sap, leaves and branches especially during windy and/or extreme weather conditions. Cherry Hill does not assume responsibility for these natural hazards or for any property damage, injury or circumstances that may result. Please take this into consideration when staying at Cherry Hill.
- **WATERPARK DISCOUNT** - All registered camping guests receive \$5 off any All Day, After 4pm, and After 6pm Splash or King pass at any ticket window through the duration of your stay. Contact the Main office for more information.

Park management is not responsible for loss, damages, or claims to property of guests due to fire, theft, accident or any other causes. The management also reserves the right to refuse service to anyone. Possession of weapons such as firearms, knives, chains, etc., is not permitted on Cherry Hill property. Cherry Hill Campground closes certain sites and areas of the campground for landscaping and maintenance throughout the season, and cannot guarantee specific sites to any guest.
